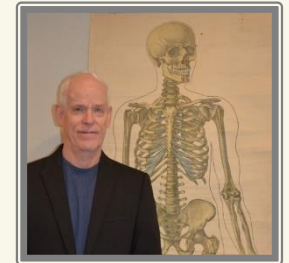

### COURSE DESCRIPTION:

Crime scene technicians, detectives, and investigators from all levels of experience, child protection team members, state and defense attorneys and nurses will benefit from this training as we cover the topic of child and infant death investigations.
