We seek an individual who will meet the challenge of becoming a court-qualified Fingerprint Analyst 2, and is able to work independently within a team environment. The ideal candidate will possess supervisory experience, Tenprint or Latent Print Certification through the International Association for Identification, knowledge of ISO-17025 accreditation standards, and knowledge of Automated Fingerprint Identification Systems.

Applicants must be a US citizen or US permanent resident prior to being hired. Applicants must have a bachelor's degree from an accredited college or university with completion of at least 12 credit hours in physical or biological science-related coursework.
